
ARTICLE 3: ACADEMIC RESEARCH PROJECTS AND TRAINING PROGRAM

6. However the company will have its exclusivity on the products developed before the MOU in and the scope of this MOU will be for the development of new products that will benefit both the institutions and for industrial training.
