## MEMORANDUM OF UNDERSTANDING

This M.O.U. is made on the 03<sup>rd</sup> day of November 2014 between St. Albert's College, Ernakulam - 682018 represented by its Principal, Sri. Harry Cleetus hereinafter referred to as **the College** and M.s. Josalayam English Medium School, Cheranellore-682034 represented by Fr. Joji Kuthukad, Parish Priest, Nitya Sahaya Matha Church, Cheranellore hereinafter referred to as **the School**.

WHEREAS the College has agreed to adopt the School and avail the facilities available in the College for motivating, encouraging and to make study interesting to the students studying in the School with the following general conditions

- 1. A minimum of 25 students from the School will be allowed to visit the College twice every year.
- 2. The students will be allowed to see/use the facilities available in the College.
- 3. The Management shall appoint a person of the College to guide the students of the School during their visit to the College.
- 4. The students of the School will be allowed to visit the laboratories, 3D Lab, Museum, Botanical Garden and Canteen etc. which are available in the College.
- 5 The School students are expected to behave according to the guidance given by the person appointed by the College.

- 8. The College shall not be responsible for any eventualities that occur during the College visit of students.
- 9. This MoU is made for three years and can be extended with mutually decided terms and conditions.

Every difference or question which may at any time arise between the parties hereto or any person claiming under them, touching or arising out of or in respect of this agreement (deed) or the subject-matter thereof and disputes arising between the parties as to the interpretation, operation, or effect of any clause in this deed or any other difference arising between the parties which cannot be mutually resolved cannot be a subject matter in any civil court and instead, it shall be referred to the Patron, The Archbishop of Verapoly. The decision of the Patron shall be binding on the parties.
