## SCOPE OF THE MOU

This MOU details the modalities and general conditions regarding collaboration between St.Albert's College and Konark Systems for enhancing, within the country, the availability of highly qualified manpower in the areas of Solar Energy Systems without any prejudice to prevailing rules and regulations in St.Albert's College and Konark Systems without any disregard to any mechanism evolved and approved by the competent authorities under Govt. of India in so far as such mechanism applies to St.Albert's College and Konark Systems. The areas of cooperation can be extended through mutual consent.

## SCOPE AND TERMS OF INTERACTIONS

- Konark Systems shall provide expert personnel as visiting faculty at St.Albert's College to teach any of the regular Course or specialized topics
- 2. Konark Systems shall provide hands-on training/on-the-job training for B.Voc. Renewable Energy students of St.Albert's College.
- 3. Konark Systems shall give joint guidance of student projects/thesis in the field of Solar Energy Systems on mutually agreeable terms.
- 4. Konark Systems may seek assistance/guidance of faculty member/s of St.Albert's College in product/process modification, modernization, trouble shooting, etc.

- 8. St. Albert's College shall acknowledge Konark Systems as its industry partner in all correspondence regarding B.Voc. Renewable Energy programme to Govt. funding agencies.

## EFFECTIVE DATE AND DURATION OF MOU

- 1. This MOU shall be effective from the date of its approval by competent authorities at both ends.
- 2. The duration of the MOU shall be for a period of 5 years from the effective date.
