- 4. The Data is to be collected from the students across different parishes (Two each from each Forane to start with) under Archdiocese of Verapoly.
- 5. SACA has the necessary expertise, research and training experience in the fields of Collecting Data and Analysing it. SACA is desirous of associating with Navadarsan in this unique venture through a multidisciplinary collaboration which will be mutually beneficial to both organizations.
- 6. SACA will provide technical consultancy for collecting the data of students who have completed their plus 2 education from 2012 onwards till 2019.
- 7. The multidisciplinary association will involve the Department of Mathematics, Statistics, Computer Sciences, Staff Members and Students of SACA.
- 8. The prescribed format, approved by **Navadarsan** will be used to collect the data of each parish which comes under the Archdiocese of Verapoly.
- 9. Navadarsan will provide the list of parishes, two each from each forane, for the preparation of the Project Proposal as deemed necessary by SACA.
- 10. Navadarsan will get the necessary permission for meeting between the Catechism Department & Education Forum Executives of the selected parishes with the members from the College.
- 11. SACA would have the flexibility to propose the method of collecting data for the effective implementation of the different levels of activities associated with data collection and analysis.
- 12. **Data** obtained will be submitted to Navadarsan by October 2020 in the format prepared for the data collection. The Evaluation result will also be submitted during the same time to Navadarsan.

Costs

13. Navadarsan will provide consultancy fees to SACA and shall also bear the documented expenses relating to Data Collection and analysis of the various data aimed at assessing/monitoring the progress of students in the parishes under Archdiocese of Verapoly. Navadarsan shall also provide travelling allowances for the scheduled visits
