4. GMI, is desirous to associate with ALBERTS, through its Department of English on various areas as discussed in the purview of this MoU, which will be mutually beneficial to both organizations.

NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS

ALBERTS and GMI recognizes that this collaboration would be of mutual benefit and would provide strengths in research and education and their mutual interest in engaging themselves in academic and industrial cooperation. As per the purpose of the said agreement, all the parties shall undertake the following activities.

5. GMI may deliver live cases/problems faced in the industry where the students of ALBERTS can have access for class-room discussion. The outcome of such discussions may be shared with GMI for evaluation/assess the practicality of the solution to the existing problem.
6. GMI will support ALBERTS in having industry experts as mentors for their students with no monetary obligation on either party and these mentors would be supporting the students for their smooth transition from Campus to Corporate.
7. GMI will deliver industry lectures at ALBERTS for the development of students with no monetary obligation on either party.
8. GMI will issue single entry passes for students from ALBERTS and any other institution proposed by ALBERTS for an industrial visit.
9. GMI will offer a one-month long internship for the students of ALBERTS, where ALBERTS shall provide the list of students who are interested to avail this internship opportunity.
10. GMI will offer placement for the students of ALBERTS and conduct Placement Drives in the college premises or GMI company premises every year (ALBERTS will provide a list of students who are qualified for the placement drive).

Costs

11. Each Party will be responsible for its own costs in connection with all matters relating to collaborations under this MoU. Where possible and appropriate, the Parties may also seek funding for collaborations from any research organization funding.
12. Where applicable, the fee for services from GMI to ALBERTS and vice-versa will be as agreed with the approvals of the signatory authorities.

Applicable Law and Jurisdiction

13. Any disputes or issues of interpretation with regard to this MoU shall be resolved amicably between the Parties. In case no amicable solution is found such disputes or issues shall be submitted to the exclusive jurisdiction of 3 arbitrators mutually agreed by the parties. The arbitration proceedings shall be conducted in English. The seat of the arbitration shall be in a mutually agreed country. This MoU shall be governed by and construed under the laws of India and would be tried in the courts in the jurisdiction of Ernakulam District.

Indemnity

14. Each Party agrees to protect, defend, indemnify and hold harmless the other Party and their related parties from and against all liability, claims, loss, damage, and costs (including legal costs and expenses) due to its failure to perform as agreed in the MoU agreement.

Assignment

15. Neither party will assign its rights or obligations under this Agreement without the prior written consent of the other party, however such requests shall not be withheld unreasonably. This Agreement will be binding upon the parties and their respective legal successors and permitted assigns.

Confidentiality

16. The parties agree that there is no intention to share any confidential or proprietary information in any collaboration under this MoU. If either Party wishes to disclose information it considers to be confidential or proprietary to the other Party, the Party needs to take prior written consent of the other party.


