And


**Department of Economics, St. Paul's College, Kerala, India**

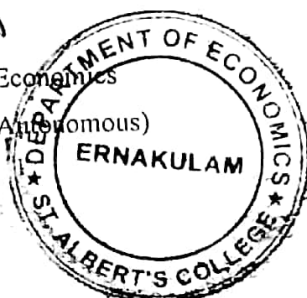
### Purpose


### Whereas

### Whereas



### **NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS**

#### **Forms of Academic and Non-academic Cooperation**

5. Both parties agree to exchange their best services and efforts in order to develop the following forms of Academic and Non-academic cooperation
  - 5.1. Faculty/Researchers/Students of DEALBERTS and DEPAULS, can collaborate in future research projects that either involve working cooperatively with partner department. Activities include, but are not limited to, efforts toward developing proposals for collaborative research, co-authoring publication, organizing joint conferences/seminars/workshops, and conducting joint research projects.
  - 5.2. Cooperate in the exchange of information relating to their activities in teaching and research in fields of mutual interests; sharing best practices adopted by each party; sharing of e-content between the parties; access to library and repository services, if possible.

  - 7.4. Special surveys

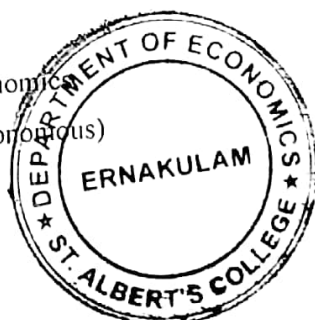
### Costs





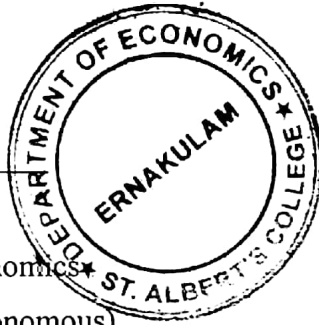
## Tenure of MoU
